## **MEDIA RELEASE: 100 ORGANISATIONS URGE MORRISON GOVERNMENT TO EXPAND *JOBKEEPER* PAYMENT TO ALL WORKERS**

Over 120 civil society, faith, business, union and migrant organisations across Australia have united to call on the Morrison Government to urgently expand its wage subsidy *JobKeeper* scheme to include all working people in Australia regardless of their visa status or how long they've been working in their current job.

Without a safety net, many migrants who contribute to our society will be trapped in Australia and living in poverty. The Morrison Government has called on these workers to return home when many of them do not have enough savings to pay for an airfare home and many do not have superannuation to draw from to survive.

The signatories to this statement (attached) know it is wrong that 1.1 million temporary visa holders are being locked out of the financial assistance that was announced for other working people and are calling on the Morrison Government and National Cabinet to show leadership and include all working people as part of the *JobKeeper* scheme.

The Morrison Government say they are proud of our cultural diversity, but these words are empty if they are leaving people behind during a time of crisis.

Australia cannot afford to leave migrant workers on temporary visas behind as we face COVID-19. Everyone in our community should be able to access real support during a public health emergency.

“If we don't expand the wage subsidy to include temporary migrant workers they will be forced on to the streets at the height of a pandemic – we can't allow this to happen and this is why over 100 organisations have come together to call for a wage subsidy that covers all workers.”



“The government’s move to leave out temporary visa holders ignores the fact that the vast majority of people on temporary visas either can’t get home because of closed borders or they do not have enough savings to pay for an airfare home.”
